From Baton Rouge:


Take I-110 until it ends at Exit 8C (toward Natchez) onto US Hwy 61

Drive 3.5 miles on Hwy 61 and exit right lane onto LA 964 (Jetson Juvenile Correctional will be on your right)

Drive 11.1 miles north on Hwy 964 then turn right onto Hwy 955

Travel 1.4 miles down Hwy955, Bill McKowen Lane will be on the left - follow long, rock driveway to shop on left.

CLASSES OFFERED (both trials):



Minimum outrun distances for HTD: 150' and, 300' for sheep; 40' and 75' for ducks.

LIVESTOCK:

Each sheep run will consist of four (4) head of Katahdin. Each duck run will consist of five (5) head of assorted breeds/crosses. Each cattle run will consist of three (3) head of assorted breeds/crosses.

Stock Replacement Fees: Sheep \$250/head; Ducks: \$50/head; Cattle: \$1800/head

Stock Replacement Rules: A head of sheep/cattle is injured if (1) it is unable to continue in the trial, or (2) blood is drawn or (3) in the sole opinion of the Committee, veterinary services are reasonably required. The Committee's decision is final.

Alternate Entries

In the event that the entry limit is reached prior to the closing date, a list of alternates will be established. Alternates for each class will be listed in the order of receipt of the entries. Alternates will be notified of their positions on the alternate's list at the time that judging programs are mailed to each entrant. Those alternates that do not have the opportunity to run shall have their entry fees refunded. Alternates must run in their respective classes if present and if provided with the opportunity to run. A maximum of eight (8) alternates will be accepted.

In the event an accepted entry is absent on the day of the test, it shall be the responsibility of the Secretary to determine if alternates are present and to determine, by their position on the alternates list, which of the alternates shall participate.

Entrants on the alternates' list must check in with the Trial Secretary no less than 30 minutes before the commencement of their class.

LIMITATIONS OF ENTRIES

These tests/trials are limited to a combined total of 20 runs per trial, no more than 8 will be ducks.

Entry fees for entries postmarked before February 28, 2019 are \$45 per run for ducks and sheep and \$65 per run for cattle. After February 18, an additional \$10 will be added for each run. The same fees apply to all runs.

Pre Entries Close: February 28, 2019 at 6 PM. Non-compete entries will be accepted as regular entries. Day of event entries will be accepted until the trial is full and close thirty minutes prior to the start of the class.



NOTICE TO EXHIBITORS:

This is a working ranch - Stay in show site area. Anyone found wandering farm fields is subject to criminal prosecution. (Attached Liability Wavier must be signed and returned with entry unless previously completed.)

- Returned check does not constitute a valid entry fee. The Trial Secretary will assess a collection fee of \$50.00 in addition to the amount of each returned check. Entries not on official AHBA entry forms are not accepted. Owners are responsible for errors in the entry form, regardless of who made such errors.
- Dogs must be ready for judging. Exhibitors are responsible for being at the arena gate when it is their turn to run.
- All dogs must be on leash at all times except when in the arena. Dogs must not be allowed to harass resting sheep.
- Nearest concessions are about 9 miles from the trial site. Complimentary coffee & snacks will be offered in the morning.
- Shade is available under trees; bring tents if you need rain cover. Bring your own drinks and chairs.
- Louisiana Ranch Dog Association and McKowen Property will exercise reasonable care for the safety of all exhibitors and dogs, but neither LRDA nor McKowen property owners will be responsible for loss or injury to any dog, handler, handler's children or property.
- * By entering this event, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all of the requirements safely.
- Bitches in season shall be eligible and will run at the end of the class in test-level classes and in catalog order as listed in the class in trial-level classes. Bitches, which appear to be heavily in whelp and unfit to participate, are to be removed by the Judge for their safety and health.
- ALL AHBA RULES REGARDING CONDUCT WILL BE STRICTLY ENFORCED on trial grounds, adjacent parking areas, and motel grounds.
