## LIMITED ENTRIES (8 hours per judge)

Entries will be limited in accordance with Chapter 1, Section 27 of the AKC Regulations. Each judge will be limited to a total of eight hours of judging time per day. Entries will be processed in the order received and time limits calculated for each judge until the 8-hour per day judging limit is reached or entries close. Obedience UDX Class and Rally RAE Class and RACH entries will be given priority.

## TRANSFER BETWEEN CLASSES

Transfers between classes within the same trial will be allowed. The request for a transfer must be in writing and presented to the trial secretary at least 30 minutes prior to the start of each trial. Transfers may be approved provided the class and judge are available, and the class has not reached its limit. Transfers between an "A" and "B" class at the same level are allowed.

## ENTRIES

- Entries must be submitted by mail on official AKC entry form or thru Showentries.info. <http://showentries.info/jotc/>.
- Entries must be complete, including signature, jump height, and proper payment of entry fees to be considered a valid entry.
- An e-mail notification will be sent when your entries are received. Official confirmations, including armband numbers, judging program, etc. will be sent via e-mail. Please configure your e-mail software to allow receipt of information from shawfrances@bellsouth.net. Be sure to check your junk mail folder. If you wish to receive conformation via US Postal Service, please include a stamped self-addressed envelope with your entry.
- A Refund of entry fees will be made for bitches that come in season after the closing date of the show. Refunds may be obtained by sending a veterinarian's certificate to the Trial Secretary. This certificate must be postmarked before the opening day of the show or given to the Trial Secretary before the start of the show.
- Changes, additions or corrections of entries must be received in writing or by email prior to close of entries.
- There will be no refund for duplicate entries.
- Refunds for cancelations made in writing before the close of entries may be charged a \$25.00 fee. No refunds will be made after the close of entries except as allowed by AKC regulations.
- RETURNED CHECKS do not constitute a valid entry fee. The Trial Secretary will add a \$30.00 collection fee to the amount of each returned check. Subsequent returned checks from the same exhibitors may result in their being put on a CASH ONLY basis.

- ◆ The Show Site will be available to exhibitors from 2:00 pm Friday and 7:00 am Saturday and Sunday. Dogs must be removed from the show site immediately after close of activities each day.
- ◆ Please bring waterproof covering to put under your crates.
- ◆ No dogs will be allowed in the restrooms by order of the Mississippi Fairgrounds Commission.
- ◆ Dumping of dog food into the restroom sinks or toilets is strictly prohibited, by order of Mississippi Fairground Commission.
- ◆ Exhibitors are responsible for picking up after their dogs on the Fairgrounds. Do not allow your dog to urinate/mark inside the building or on the front of the building.
- ◆ Per Sections 1 & 2 of AKC's Dealing with Misconduct, the Show Committee reserves the right to retain Show Committee jurisdiction over exhibitors whose names have been referred by hotels/motels as having left their rooms and/or grounds in a state that appears negligent or offensive. - (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
- (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e. A or B division.

- Dogs listed in the **AKC Canine PartnersSM Program** may be eligible to enter all-breed AKC Obedience trials at the club's option. These dogs should be listed as All American Dog and must include their AKC Number on the entry form and check the AKC No. box. Sire and Dam information shall remain blank for mixed breed entrants.

Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify, defend and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this event, however such, injuries, death or property damage may be caused, and whether or not the same may have been caused or may be alleged to have been caused by the negligence of the aforementioned parties or any of their employees, agents, or any other person. I (we) agree that the determination of whether the injury is serious shall be made by the event veterinarian and is binding on me (us). **I (WE) AGREE THAT ANY CAUSE OF ACTION, CONTROVERSY OR CLAIM ARISING OUT OF OR RELATED TO THE ENTRY, EXHIBITION OR ATTENDANCE AT THE EVENT BETWEEN THE AKC AND THE EVENT-GIVING CLUB (UNLESS OTHERWISE STATED IN THIS PREMIUM LIST) AND MYSELF (OURSELVES) OR AS TO THE CONSTRUCTION, INTERPRETATION AND EFFECT OF THIS AGREEMENT SHALL BE SETTLED BY ARBITRATION PURSUANT TO THE APPLICABLE RULES OF THE AMERICAN ARBITRATION ASSOCIATION. HOWEVER, PRIOR TO ARBITRATION ALL APPLICABLE AKC BYLAWS, RULES, REGULATIONS AND PROCEDURES MUST FIRST BE FOLLOWED AS SET FORTH IN THE AKC CHARTER AND BYLAWS, RULES, REGULATIONS, PUBLISHED POLICIES AND GUIDELINES.**
